ANNUAL REPORT, 2019 THE ARUNACHAL PRADESH INFORMATION COMMISSION

CHAPTER-I

INTRODUCTION

Freedom of information is a fundamental human right and this was recognized by the United Nations at its very inception in 1946 when the General Assembly resolved: "Freedom of Information is a fundamental human right and the touchstone for all freedoms to which the United Nations is consecrated" Enshrined in the Universal Declaration of Human Rights, the right's status as a legally binding treaty organization was affirmed in Article-19 of the International Covenant on Civil and Political Rights which states – "Everyone has the right to freedom of opinion and expression: this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers". This has placed the right to access information firmly within the body of universal human rights law.

This right to information was explicitly held to be our fundamental right under Article-19(1)(a) of the Constitution of India for the first time by Justice K.K Mathew in the *State of U.P -Vs- Raj Narain*. This view was followed by the Supreme Court of India on numbers of decisions and, after public demand; the Right to Information Act, 2005 was enacted and brought into force.

The RTI Act is not new for India. Many of its States have already enacted similar Acts in the past. The RTI Laws were first successfully enacted by some State Governments of our Country, like – Tamil Nadu and Goa in 1997, Rajasthan and Karnataka in 2000, Delhi in 2001, Maharashtra and Assam in 2002, Madhya Pradesh in 2003 and Jammu & Kashmir in 2004. And there had already been a Law enacted called as 'the Freedom of Information Act, 2002'. In order to ensure greater and more effective access to information the Government of India decided to repeal the Freedom of Information Act, 2002 and to enact another law for providing an effective framework for effectuating the right of information recognized under Article-19 of the Constitution of India. To achieve this object, the Right to Information Bill was introduced in the Parliament. The Right to Information Bill, having been passed by both the Houses of Parliament, received

the assent of the President on 15th of June, 2005 and finally the same came into being as 'the Right to Information Act, 2005 (Act 22 of 2005)'. Some provisions of the Act came into force with immediate effect from 15th June, 2005 when the President gave his assent so that the public authorities could make preliminary arrangements for implementation of the Act in the field of: designation of Central/State Public Information Officers; designation of Central/State Assistant Public Information Officers; designation of First Appellate Authorities senior to Public Information Officers; framing of rules for smooth Act; setting up of Central/State Information implementation of the Commission(s); preparation of 17 manuals for dissemination of pro-active information, etc. And the Act later fully came into force in our Country, including in the State of Arunachal Pradesh, on 12th of October, 2005 after 120 days of enactment of the Act.

The Right to Information Act, 2005, is the first ever 'sunshine law' enacted by the Parliament which extends to the whole of India, in as much as, like most 'sunshine laws' it provides a right to all citizens to demand information from any public authority in India while also creating a positive obligation upon these authorities to pro-actively publish information about their functioning. It has been made applicable to all public authorities, viz, all Central and State Government Ministries; Departments; Organizations; Undertakings, Autonomous Bodies, Municipalities, Panchayat, etc, enacted by law and also covers the Union Territories. The Judiciary and the Legislature including Parliament and State Legislature are also covered under its purview.

The Right to Information Act, 2005, has been enacted to provide for setting out the practical regime of right to information for citizens. The basic objectives of this Act are to: empower the citizen to get information from any public authority; to promote transparency and accountability in the workings of the Government and its instrumentalities; to contain corruption and; to make our democracy work for the people in real sense.

The Right to Information Act, 2005, is divided into six chapters and contains thirty-one sections in the whole. All these sections of the Act had remained intact for a period of more than 14(fourteen) years from the date of its enactment on 15th of June, 2005. After such a long period of more than 14 (fourteen) years as aforesaid an amendment bill called as 'the Right to

Information (Amendment) Bill, 2019' was introduced in the Lok Sabha by Minister of State for Personal, Public Grievances and Pension, Mr. Jitendra Singh on 19th of July, 2019 and the same which was passed by the both Houses of the Parliament was given assent to by the President of India on the 1st day of August, 2019 called as 'the Right to Information (Amendment) Act, 2019 (24th Act of 2019)' and by which provisions of Section(s)-13, 16 and 27 of the Principle/Original Act of 2005 have now been amended. And accordingly, the Ministry of Personnel, Public Grievances and Pensions (Department of Personnel and Training) Govt. of India (Central Govt.) while in the exercise of Power conferred by clauses (ca) and (cb) of sub-section (2) of Section-27 of Right to Information Act,2005 frame the Rules, Vide Notification, New Delhi, the 24th October ,2019 called as the "Right to Information" (Terms of Office, Salaries, Allowances and Other Terms and Condition of Services of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioners and State Information Commissioners in the State Information Commission.) Rule, 2019 which came into force with immediate effect on this date of the Notification.

A BRIEF ABOUT ARUNACHAL PRADESH INFORMATION COMMISSION

The Right to Information Act, 2005 is a landmark legislation that has transformed the relationship between the citizen and the state. This legislation has created for every citizen to hold the instrumentalities of Governance accountable on day to day basis. The legislation perceives the common man as an active participant in process of nation building by conferring on him the right to participate in the process through the implementation of Right to Information Act.

It has been more than 14 years since the RTI Act has been in operation in the state of Arunachal Pradesh. Akey strength of the Act pertains to administrative and adjudicative autonomy of Information Commission.

The Right to Information Act 2005 came into force in Arunachal Pradesh along with the rest of the country on 12th October 2005 after 120 days of its enactment. As per the provisions of this Act, State Public Information Officers (SPIO) and Assistant Public Information Officers (APIO) were appointed by the Government of Arunachal Pradesh under separate notifications. In pursuance to the provisions of Clause 3 of Section 15 of the Right to Information Act, a selection committee was constituted for the appointment of State Chief Information Commissioner and State Information Commissioners. On 13th October 2006, Arunachal Pradesh Information Commission (APIC) was constituted and the State Chief Information Commissioner Shri NyodakYanggam and State Information Commissioners Shri Bani Danggen, Shri HabungPayeng and Shri NipoNabam were administered the oath of office by His Excellency Governor of Arunachal Pradesh, on 19th October 2006.As per Notification No. OM/51/2005/390 dated 14.11.2007 Shri Toko Anil was appointed as 4th SIC and was sworn in on 3rd December, 2007.

As provided under section 15 (1) of The Right to Information Act, 2005, the Governor of Arunachal Pradesh constituted the Arunachal Pradesh Information Commission vide Notification No. OM-51/2005 dated 13.10.2006 with 1 (one) Chief Information Commissioner and 3 (three) Information Commissioners with immediate effect. In exercise of the powers conferred by the Section 15 of the Right to Information Act 2005 (No.22 of 2005) and in partial modification of the Notification No. OM-51/2005 dated 13.10.2006, the Governor of Arunachal Pradesh constituted the Arunachal Pradesh Information Commission

with a Chief Information Commission and 4(four) Information Commissioners with immediate effect vide Notification No. OM-51/2005/396 dated 14.11.2007

The Commission started functioning after getting office accommodation at Secretariat Annexed building in the first week of December 2006 with office functionaries provided by the State Government. The Commission thereafter, entertained complaints, appeals and initiated proceedings to dispose of all the cases in accordance with the provisions of the RTI Act. It also started monitoring the implementation of RTI Act and issued necessary instructions to various departments to comply with the provisions of RTI Act. The Commission has strived to educate the public and officials for proper implementation of RTI Act with the help of the State Government. Due to dismantling of the State Civil Secretariat for construction of new buildings, the Arunachal Pradesh Information Commission was shifted to Hotel Bomdila on 5th November 2008. The Commission continuedfunctioning from the same place without proper facilities court room, office chamber, furniture, library accommodation and supporting staffs and was delivering its duties under pathetic conditions.

However, the Commission has been shifted to the present location – earlier Planning Department premises, opposite to the Legislative Assembly, Arunachal Pradesh, since 28thFebuary 2017

The Arunachal Pradesh Information Commission (APIC) has been rendering wonderful services for transparent and good governance since its inception in the state of Arunachal Pradesh since 2006. It is worth mentioning here that in the year 2009, the Arunachal Pradesh Information Commission was awarded the best InformationCommission of India for its effective implementation of Right to Information Act, 2005 in the state. This award was initiated by The Public Cause Research Foundation (PCRF), a Ghaziabad based NGO.

Shri Y.D. Thongchi, IAS (Rtd.) was appointed as the State Chief Information Commissioner and was administered oath of office on 1st March, 2011, as ShriNyodekYonggam demitted the post on 28thFebruary 2011. On 6th Oct'2015, the Arunachal Pradesh Information Commission bade farewell to Chief Information Commissioner Shri Y. D. Thongchi on his attaining the age of 65 as per section 16 (1) of the Right to Information Act, 2005.

Four Information Commissioners, ShriMatheimLinggi, SmtiNanomJamoh, ShriEkenRiba and Shri Abraham K. Techi were appointed as State Information Commissioners of Arunachal Pradesh Information Commission (APIC) on 2nd January 2014 vide Notification F.NO. Ar-113/2011 and took Oath of office on 8th

January 2014. Shri EkenRiba, SIC demitted office on 27/7/2016 on attaining the age of 65 years under section 16(2) of the RTI Act 2005.ShriMatheimLinggi, SmtiNanomJamoh and Shri Abraham K. Techi demitted their office on 7th January, 2019 after completion of their tenure of 5 years.

Dr. JoramBegi has been appointed as the State Chief Information Commissioner (SCIC) on 28th June, 2016 and was administered oath of office on 10th July, 2016 by the Hon'ble Governor, Shri Thatagata Roy. Shri GotoEte was appointed as State Information Commissioner vide order No. AR-19/2017/142 dated 7th May, 2018 and was sworn in on 16th June, 2018 by the Hon'ble Governor, Brig (Dr.) B D Mishra (Rtd). Shri LekiPhuntsowas appointed as State Information Commissioner vide order No. AR-133/2018 dated 4thJune, 2019 and was administered oath of office on 26th July, 2019 by the Brig. (Dr.) B.D Mishra

<u>ACTIVITIES UNDERTAKEN BY THE ARUNACHAL PRADESH</u> INFORMATION COMMISSION

STATE CONVENTION ON RTI Act, 2005 CUM THE 13TH FOUNDATION DAY CELEBRATION.

The commission has organized the State Convention on RTI Act, 2005 cum-the 13th Foundation Celebration of the Commission on 19th Oct 2019 in the State capital at D.K Auditorium Arunachal Pradesh Legislative Assembly.

The Governor of Arunachal Pradesh B.D Mishra (Rtd) and Himangshu Sekhar Das CIC Assam graced the occasion as Chief Guest and Guest of Honour. The Governor in his inaugural address as Chief Guest, adding it encourages Government to ensure and administration honestly by its effective compliances and voluntary disclosure for good Governance. He also dwelt that good Governance has seven pillars: - transparency, accountability, honesty, cordiality, audit, review and mid-course correction. The Act also protect fundamental rights, prevent human rights violations, provide exigency in getting justice, eliminating administrative procrastination, prevention of procedures and provisions.

Shri Himangshu Sekhar Das as Guest of Honour in his speech, terming RTI Act 2005 as hidden Act and wondered to why the Act is not applied to seeking information from private service provides like health, education, transport Service, airlines, T.V Channels etc. The Act has come a long way since 1789 French Revolution and good tool for a democratic society.

Dr. JoramBegi in his key note address appreciating the Governor and he termed him as "Karmvir Governor" and a true exponent of RTI Act 2005. A power point presentation on effective implementation of RTI Act was presented during the function by the SIC, Shri GotoEte and its inaugural function was concluded with the presentation of vote of thanks by the SIC, Shri LekiPhuntso.

The function was also attended by former CIC, Shri NyodekYonggam, and Y D Thongchi and chair personSmtiTseringYongjam Das the 6th Finance Commission of Assam. MLA DasangluPul, NyatoRigia and TarinDakpe also A. K Techi, M. Linggi and NanomJamohwere panelist and moderator during the interactive session.

The function was attended by HOD, Professors, Dean, faculty members, students of Jote Law Academy, RGU, Doimukh Govt. College, Jollang Don Bosco College, DNGC and Aalo-Base North East Frontier Technical University besides RTI Activist, Official and youths of the State.

Awareness programme on RTI Act, 2005 at Longding, Khonsa and Changlang District.

Arunachal Pradesh Information Commission (APIC) has conducted awareness programme on RTI Act, 2005 at Longding, Khonsa and Changlang District. Dr. JoramBegi Chief Information Commissioner (CIC) along with State Information Commissioners (SICs) Shri GotoEte and LekiPhuntso continue the said mission to educate the mass of Eastern Arunachal Pradesh. Dr. JoramBegi with the said two Information Commissioners have held meeting to educate the mass including Officers, leaders, GBs, and students about the role of Arunachal Pradesh information Commission. The Longding meeting received overwhelming response with participation of local MLA TapanphoWangnaw, DC Chesta Yadav, SP Bharat Reddy P Reddy, GBs, villagers and large number of students. After holding such meeting at Longding a team proceeded to Khonsa and Deputy Commissioner P.N Thungon and other HODs greeted the team with a welcome and hospitality and assisted the team for successful conducting the campaign at Khonsa on 28th September 2019. After completion at khonsa the team further proceeded to Changlang District where Deputy Commissioner R.K Sharma accommodated the other HODs, warmly welcome the team and assisted the team for conducting the awareness campaign at Changlang. On completion of the awareness campaign at Changlang the team conducted its tour programme to the Eastern Arunachal Pradresh

Inaugural Sessionof 14th Annual Convention of Central Information Commissionat New Delhi.

The Two Commissioners Shri LekiPhunto, SIC and Shri GotoEte, SIChas represented the Arunachal Pradesh Information Commission and attended the inaugural session of 14th Annual Convention of CIC at New Delhi, on 12th October, 2019, in which Union Minister for Home Affairs, Shri Amit Shah presidedover the function as Chief Guest.Union Minister of State for Development of North Eastern Region (Independent Charge); Prime Minister's Office; Personnel, Public Grievances and Pensions; Departments of Atomic Energy and Space, Dr. Jitendra Singh was the Guest of honour. All present and former Chief Information Commissioners and Information Commissioners of the Central Information Commission, CICs and ICs from State Information Commissions as well as the First Appellate Authorities & Central Public Information Officers were invited for the annual convention. Some nominated NGOs working at ground level were also invited to participate in the Convention.

In 2019 the Commission has registered 178 cases and disposed of 127 cases and imposed penalty in 11 cases amounting to Rs. 2,35,000/-, Awarded compensation in 11 cases amounting to Rs. 82,000/-, servedas many as 3 (three) Civil warrant of arrest against PIOs during this period and 1 disciplinary action case under service rules against delinquent PIO.

Section 25 of the Right to Information Act provides that the Central Information Commission or the State Information Commission shall prepare a report on the implementations of the provisions of the Act after the end of each year and forward the report to the appropriate Government for laying it before the Parliament or the State Legislature. Hencetheannual report for 2019isprepared in compliance with Section 25 sub-section (1) of the Right to Information Act after compiling all the required Information received from different Public Authorities of Arunachal Pradesh.

 - VI. For inspection of Records: No fee for first Five rupees
 - VII. Hour and for the subsequent each 15 minutes
 - VIII. (or fraction thereof)

1. Short title commencement: -

- (1) This rule may be called the Arunachal Pradesh Right to Information (1st Amendment) Rules, 2006.
- (2) They shall come into force from the date of their publication in the Arunachal Pradesh Gazette.
- 2. Amendments: In the Arunachal Pradesh Right to Information Rules, 2005 (hereinafter called the Principle Rules);
- (1) For clause (b) of sub-rule (1) of Rule 2, the following clause shall be Substituted, namely:
 - "(b)"Competent authority" means the Public Information Office (PIO) or such Officer who is senior in rank to the Public Information Officer as the case may be".
 - (2) In rule 3 of Principal Rules; the following proviso shall be inserted namely:
 - "Provided further that the PIO/APIO shall assist the person requesting forInformationin filling up the form-A to ensure complete details of informationrequired. Provided further that person's residing outside the Capital Complex as well asDistrict headquarters are allowed to applyon plain paper."
 - (3) In Rule 4 of the Principal Rules, (i) for Sub-clause (1) following sub-ruleshall be substituted by the following namely:(i)"(1) If the requested information does not fall within the jurisdiction of the competent authority, it shall transfer the remaining part to the concerned PIO/APIO of the Department/office with intimation to the applicant in form 'B' as soon as

practicable, normally within fifteen days and in any case within thirty days of the receipt of the application, advising the applicant. Wherever possible, about the competent authority to whom the applicant should approach for the remaining part of the information. The application fee deposited in such cases shall not be refunded, nor is the applicant liable to pay application fee again on transfer of application for the remaining part of the information".

- (ii) For sub-rule (3), the words, "reject the remaining part giving reasons thereof" shall be substituted by the words, namely:
- "Transfer the remaining part to the competent authority of the concerned Department/Office thereof. Provided that the application for information shall not be rejected unless it is exempted from discloser".
- (4) In Rule 5 of the Principal Rules, Sub-clause 3 (a) & (b) shall be omitted. (5) In Rule 6 of the Principal Rules, Sub-Rule (1) shall be omitted.
- (6) In Rule 8 of the Principal Rules,
- (1) for-clause (ii) of Sub-Rule (1) (A), the following clause shall be Substituted, namely:"
- (ii) Information in the form of -Two rupees per page, Communication/letter etc.
- (iii) for-serial number-2 of Sub-Rule (1)(B), the following shall be substituted namely:
 - (2). For other than priced publication -Two rupees per page"
- (iii) in clause (B) of Sub-rule (1) of rule 8, after serial No. 2, the following serial number and entries shall be added namely:"
- (3) For inspection of records, no fee for Rupees five". the first hour; and for each subsequent hour (or fraction thereof).

CHAPTER-9

RECOMMENDATION OF THE COMMISSION TO THE STATE GOVERNMENT

As per Section 25 (3)(g) the Commission would like to make the following recommendation to the Government of the Arunachal Pradesh for effective implementation of the RTI Act in the state.

REGULAR REPORT RETURN FROM PUBLIC AUTHORITIES

Although Sub Sections (2) and (3) of Section 25 of the RTI Act mandate that each Ministry and Department in relation to the Public Authorities within their jurisdication, shall collect and provide such information to the State Information Commission, as is required to prepare the Annual Report. It has been found that only 78 State Public Information Officers (PIOs)/APIOs out 310, have submitted the report return for the purpose. The State government, through the nodal department should direct all the PIOs to submit the quareterlyreport of the Public Authority as specified under the provisions of section to the State Information Commission regularly.

INADEQUATE PERFORMANCE OF THE FIRST APPELATE AUTORITY

As per Section 19(1) Any person who does not receive decision within the time specified or aggrieved by the decision of the State Public Information Officer (SPIO), may within 30 days from the expiry of such period or from the receipt of such a decision, prefer an appeal to such officer who is senior in rank to the State Information officer in each public authority.

It has been observed that this provision of First AppelateAutority is being done by a very few public authorities and most of the First Appellate Authorities do not function in the state so much so that, the department of Administrative Reform (AR) the nodal department, has not yet brought out the Rules on the First Appellate Authority.

For effective implementation of the Act, the provision of the First Appellate Authority (FAA) is to be complied with strictly. For this, the appropriate initiative is required from the nodal department of the government.

PROACTIVE DISCLOSURE

As per Section 4 of the RTI Act, it is the obligation of every Public Authority to disclose certain information onSuo Motu basis as laid down under sub-section (1) of the Section.

As per Sub Section (2) of the Section, it shall be a constant endeavor of every Public Authority to take steps in accordance with the requirements of the clause (b) of the Section 1 to provide as much information Suo-Motu to the public at regular intervals through various means of communication including internet, so that public have minimum resourt to the use of the Act to obtain information.

It has been observed that most of the Public Authorities are not strictly complying with the provisions of the Section proactive disclosure of the activities undertaken by the Public Authority. It is also, abserved that many of the Public Authority not even having website containing upto date information. If more and more Suo-Motu disclosure is made by the Public Authorities, undoubtedly there would be less and less people to resort to this Act for seeking information. Therefore, the Commission recommends that the Chief Secretary of the State should direct all the Public Authorities of the state to comply with the provisions of the Act strictly.

ORDER

Whereas, on receipt of an appeal under Section 19(3) of RTI Act, 2005 from Shri Tagar Mibang, Village Riga, PO-Riga, PS-Boleng, District-Siang, Arunachal Pradesh, for non-furnishing of information as sought by the appellant under section 6(1) of RTI Act,2005 on09.03.2018, summon notice was issued to Shri Tanyang Tatak, the PIO-cum-DDSE, Pangin for appearance before the Hon'ble Court of Dr. Joram Begi, the State Chief Information Commissioner, for hearing with an intimation to the appellant.

Whereas the 1st hearing was held on 17.05. 2018. Shri Birbal Rai, the APIO-cum-CRLC and shri Amitabh Pejik DPC (MDM) represented the PIO. The appellant informed that he had received the informations for the year 2017-18

only whereas he has sought from the year 2012 to till date. The APIO replied that some of these informations are pertaining to the period prior to the bifurcation and hence these are available with the PIO-cum- DDSE, East Siang District, as the Siang District started functioning from 2nd quarter of 2015. The Commission decided to summon the

PIO-cum-DDSE, East Siang as 2nd Respondent to appear in the next hearing. The APIO-cum-CRLC was also directed to contact to the appropriate person from his side so that the informations can be furnished to the appellant. Further, the Commission pointed out that the informations sought under Sl.no. 2 & 3 are of same nature and hence the rate of honorarium as sought under Sl.no 2 be furnished.

Whereas the 2nd hearing was held on 28.08. 2018. Shri Birbal Rai, the APIO-cum-Coordinator and Shri Amitab Pejik, DPC (MDM) represented the DDSE of Siang District. Shri T.Dabi the APIO-cum-Head Master represented the DDSE of East Siang District, Arunachal Pradesh. Shri Tagar Mibang, the appellant was also present. After hearing from both the parties, the Commission ordered as follows:

- 1) The PIO of Siang District: to furnish the list showing the name of Cook-cumhelper and the evident of the honorarium paid to them from existing eligible schools for the period from 2nd Qtr. Of 2015 to 2017.
- 2) The PIO of East Siang District: to furnish the list showing the name of Cookcum-Helper and the evident of the honorarium paid to them from existing eligible schools for the period from 2012 to 1stQtr of 2015.

Whereas, the 3rd hearing was held on 18.09.2018. Both the parties were present. The PIO of Siang District brought the documents as per direction of the previous order and handed over to the appellant during the hearing. The appellant sought the actual receipt of the honorarium paid to the cook cum helper. The PIO clarified that they have indicated the year wise installments against which payment was made.

The PIO of Siang District also brought the information as per direction of the previous order of this court and handed over to the appellant. The BEO also informed that some of the informations he was unable to furnish because these were totally destroyed in a fire accident in his office. He has also submitted a certificate obtained from the Police Station.

The Commission had directed the DDSEs of both Siang and East Siang Districts to furnish the remaining available information within the 10th October 2018.

Whereas, the 4th hearing was held on 16.10. 2018. Shri Birbal Rai, the APIO-cum-Coordinator, ShriAmitabPejik, DPC (MDM) represented the DDSE of Siang District, Shri Tage Aje, APIO-cum- Dist. Coordinator (MDM) East Siang and Shri Tagar Mibang the appellant were present. The appellant informed that out of total 84 (eighty four) schools only the information provided by the Rengo Middle School was found satisfactory and rest of the schools have provided incomplete information. On the query of the Commission, the APIO informed that they had issued a letter to all the Headmasters and the Teacher incharges to provide information in detail but they have failed to adhere to the notice issued. The APIO requested for some more time to be given, so that they could call meeting and instruct Headmaster and Teacher Incharges to provide detail information at the earliest. On their request the Commission had given last chance to produce the information or give a speaking order as to why the money receipts/Acquaintance Roll of the cook cum helpers could not be furnished in the next hearing date, else penalty will be imposed.

Further, Shri Tanyang Tatak, PIO-cum-DDSE Pangin, Siang Districtis had been directed to attend in person without fail in the next date of hearing. If he was found absent in the next date of hearing, arrest warrant under section 18(3) (a) wasto be issued and also under section 20(1) penalty was to be imposed on the PIO.

Whereas the 5th hearing was held on 13.11.2018. Both the parties were present. While investigating it had been found that the honorarium for the Cookcum-Helper of MDM scheme of schools in Siang District had been received by the Head Master/BEO etc and it was not known whether the payment had actually been made to the concerned Cook-cum-Helper of the MDM scheme or not.

Therefore, the PIO-cum-DDSE, Siang District had been directed to furnish Acquaintance Roll/money receipt duly signed by the concerned Cook-cum-Helper of each school from July, 2015 to 31.03.2017. The DDSE had to identify all Head Master/ BEO etc., who were involved in the disbursement of the amount in each school during the period and fix the responsibilities on them if they are unable to furnish the required documents. This had to be done within a period of 20 days and thereafter the information to be furnished to the appellant.

The action taken report was to be submitted in the next date of hearing.

Whereas the 6th hearing was held on 11.12. 2018. Shri Birbal Rai, APIO on behalf of PIO was present. The appellant Shri Tagor Mibang was also present. After hearing both the parties the Commission ordered the APIO to furnish the remaining informations as mentioned below without further delay:

- 1) The list of all eligible schools under Siang District,
- 2) The list of Cook-cum-helper indicating the name and date of appointment and also payment details to them.

The Commission further cautioned that if the PIO fails to furnish the above said informations to the appellant within 10th January, 2019 penalty shall be imposed on him under section 20(1) and also compensation to the appellant under section 19(8)(b) of the RTI Act,2005

Whereas, the 7th hearing was held on 15.01.2019.ShriBirbalRai, APIO on behalf of PIO was present. The appellant Shri Tagor Mibang was also present. The APIO furnished the information on the day of hearing instead of doing the same within 10th Jan'2019 as directed in the last hearing. On cursory looking at, all schools did not have the mention of cook-cum-helpers. However, the appellant was to go through it and convey his satisfaction. Therefore, the next day of hearing was fixed.

It was also made it clear that the hearing of this case cannot be prolonged any longer. Therefore, ShriTanyangTatak, PIO-cum-DDSE, Pangin, District Siang Arunachal Pradesh was asked to be present in person in the next hearing and explain the reason why penalty under Section 20(I) and also compensation to the appellant under Section 19(8)(b) of the RTI Act 2005 should not be imposed on him for delebrate delay and incomplete furnishing of informaitons.

Whereas 8th hearing was held on 19th February'2019.Shri Tanyang Tatak, PIO-cum-DDSE Pangin, District Siang Arunachal Pradesh and the appellant Shri Tagar Mibang were present. The appellant informed that he has received only the information of 42 schools and that too are incomplete. The PIO informed that out of total 86 schools only 69 schools are eligible under MDM scheme. The PIO also admitted that the remuneration to the Cook cum helper was not paid in some schools and the amount was kept with Headmaster due to the absence of the Cook cum helper. So, they contacted the Cook cum helper and tried to pay the remunerations but they did not turn up.

Whereas, the Commission noted and made observation that paying remuneration at this point of time itself is irregular and asked the PIO if remuneration was not disbursed timely, why the amount was not returned to the government exchequer?

Why, disciplinary proceedings initiated against the erring officials / teachers for keeping the government money with them for such a long period of time? The PIO could not give satisfactory and justifiable answer.

Whereas, the Commission has given reasonable opportunity to the PIO to furnish information or give convincing reasons in written for non availability of informations as sought by the appellant. The PIO could not follow the orders and directions of the Commission. Therefore, penalty of Rs. 25, 000.00 (Rupees twenty-five thousand) only under Section 20(1) of the RTI Act 2005 is imposed and also, he has been asked to compensate the appellant under section 19(8)(b) of the Act, the exact amount for the compensation will be decided in the next hearing. Further, the Commission cautioned the PIO that if he fails to furnish the remaining information and deposit penalty within 10 days in favour of the Registrar, Arunachal Pradesh

Information Commission, Itanagar through Treasury Challan in the Head of Account "0070-Other Administrative Charge" and pay the compensation to the appellant, a disciplinary proceeding under Section 20(2) shall be recommended.

Whereas, the 9th hearing was held on 19.03.2019. Shri Amitab Peijik, APIO-cum-DPC(MDM), Pangin, District Siang Arunachal Pradesh and Shri Banboh Nyitam, representative of the appellant Shri Tagar Mibang were present during the hearing.

Whereas, the appellant Shri Tagar Mibang submitted a letter No. NIL Dated 19/03/2019 through his representative stating that he has received all the information free of cost from the PIO and is satisfied with the information furnished to him.

Whereas, the appellant did not turn up to claim compensation as per the last hearing order, therefore, the compensation stands cancelled. The APIO submitted a copy of Challan No. 23644 Dated 21/02/2019 as a proof for the penalty deposited in the Head of Account "0070-Other Administrative Charge".

In view of the above, the case is hereby disposed of.

Whereas, an appeal under Section 19(3) of RTI Act, 2005 has been received from Ms. OyingPertin,C/o ShriTummeAmo, Near Statistics and Economic office,P/o Gohpur, Itanagar, Arunachal Pradesh, for non-furnishing of information as sought by him under section 6(1) of RTI Act,2005 on16.07.2018.

Whereas, the 1st hearing was held on 13.11.2018. Shri Bate Koyu, PIO-cum-Dy. Secretary, Arunachal Pradesh Public Service Commission, Itanagar and the appellant Ms. Oying Pertin were present. The appellant informed that she has not got any information as sought by her. In reply, with the documentary evidences, the PIO informed that 3(three) third party denied to produce their answer sheet to the appellant. The PIO also said that the First Appellate Authority under Section 19(1) has conducted hearing of past order to the effect but the order could not be delivered to the appellant due to unavailability of her proper address. The Order has been delivered to the appellant during the hearing.

After, hearing both the parties the Commission decided to summon all the 3(three) third parties namely **Taku Tajo Renu**, **Lilimang Modi and Neetu Wangsu**under Section 19(4) of the RTI Act 2005 in the next date of hearing.

Whereas, the 2nd hearing was held on 11.12.2018. Shri Bate Koyu, PIO-cum-Dy. Secretary, Arunachal PradeshPublic Service Commission, Itanagar, the appellant Ms. OyingPertinand the third parties i.e. the qualified candidates for the GDMO(AYURVEDA)Exam/2018 namely, MissTaku Tajo Renu, Miss LilimangModi and Miss NeetuWangsuwere present.

The Commission made it clear to the qualified candidates that the answer sheets after the selection process is over, are now a mere document and is no longer confidential. Therefore, there is no reason why it cannot be furnished to the appellant. The qualified candidates agreed to allow the disclosure and providingXerox copies of their answer sheets to the appellant.

Therefore, the Commission directed the PIO to furnish the Xerox copies of answer sheets of Paper-II, GDMO (AYURVED) Exam-2018 of the three qualified candidates within 10(ten) days from the receipt of this Order to the appellant. The PIO gracefully agreed to do so. The Commission also directed the appellant to give in writing of her satisfaction on receipt of the same.

Whereas, 3rd hearing was held on 15.01.2019. Both the parties i.e. the PIO and the appellant were absent during the hearing. Telephonically, the Commission was informed that the informations sought by the appellant has been sent through post and the PIOalso assured that, if necessary the PIO will provide informations to the appellant personally.

Therefore, the case is hereby disposed of.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section-19 of the RTI Act. Brief fact of the case is that the appellant Shri PhurpaTsering& 4(four) others named above, jointly filed an RTI application on 20.09.2018 under Form-A of the RTI Act before the PIO-cum-ADC, Dirang, seeking various information's regarding land compensation payment against 27.55 Acres of Community Land of Lish Village. Details of information sought in this RTI application are as follows:

- 1. On 29.08.2017, Rs.25,00,000/-(twenty five lakhs) only was paid to YeshiTsewang through REF/CHQ NO.00000126433. Mention reason for payment of this amount to this person.
- 2. On 06.09.2017, Rs.1000,000/-(ten lakhs) only was paid to YeshiTsewang through REF/CHQ NO.00000126437. Mention reason for payment of this amount to this person.
- 3. On 07.09.2017, Rs.200,000/-(two lakhs) only was paid to LeikiKhandu through REF/CHQ NO.00000126438. Mention reason for payment of this amount to this person.
- 4. On 11.09.2017, Rs.1000,000/-(ten lakhs) only was paid to LeikiKhanduThongkhar through REF/CHQ NO.00000126440. Mention reason for payment of this amount to this person.
- 5. On 05.10.2017, Rs.00,000/-(three lakhs) only was paid to LeikiKhandu through REF/CHQ NO.000001264532. Mention reason for payment of this amount to this person.

- 6. On 10.10.2017, Rs.50,000/-(fifty thousand) only was paid to LeikiKhanduThongkhar through REF/CHQ NO.00000126481. Mention reason for payment of this amount to this person.
- 7. On 24.10.2017, 1000,000/-(ten lakhs) only was paid to 'Self' through REF/CHQ NO.00000126533. Mention reason for payment of this amount to this person.
- 8. On 11.12.2017, 50,000/-(fifty thousand) only was paid to DorjeeKhandu through REF/CHQ NO.00000126539. Mention reason for payment of this amount to this person.
- 9. On 18.12.2017, Rs.840,000/-(eight lakhs forty thousand) only was paid to LeikiSangia through REF/CHQ NO.00000126540. Mention reason for payment of this amount to this person.

Shri Toko Babu, the PIO-cum-ADC, Dirang, having receipt of the same, responded to the appellants vide his letter vide No.No.DRG/GA/RTI-47/2018-19/5665-67 dated-08.11.2018 to the effect, among others, that his office deposited the amount in joint account of GBs of Lish/LishGompache Village A/C No.66241010000200 (canara bank). The appellants, being not satisfied with the information received from the PIO, filed the First Appeal before FFA-cum-Deputy Commissioner, West Kameng District, Bomdila, on 04.12.2018 on a lone ground of furnishing incomplete information to them by the PIO. The FAA-cum-Deputy Commissioner, Bomdila, vide his order No.BJ/RTI-2/15 dated-21.12.2018 passed an order refixing the final date of hearing of the First Appeal on 15.01.2019 at 1100 hours as the PIO-cum-ADC, Dirang, was found absent during hearing of the First Appeal fixed on 18.12.2018. The appellant, appearing to be aggrieved by getting incomplete information from the PIO in the proceeding before the First Appellate Authority, filed this Second Appeal before this Commission on 21.01.2019. The Registry of the Arunachal Pradesh Information Commission accordingly registered the appeal, being the present appeal as APIC-16/2019 and issued processes for hearing of the appeal.

This appeal came up for hearing before the Commission for as many as 5(five) times, i.e, on 27.02.2019, 20.03.2019, 15.05.2019, 29.05.2019 & 03.07.2019. The PIO attended almost on all dates of hearing of this appeal. But, in contra, the appellants, who filed this appeal before this Commission, inspite of repeated notices to them being issued, remained completely absent during all dates of hearing of this appeal for the reason not known, in as much as, none of these five appellants, inspite of repeated notices to them being issued, has ever given any information or intimation to this Commission about their inability, for whatsoever reason, to attend in any of those dates of the hearing of the appeal. It is not out of place to mention herein that right from beginning of hearing of this appeal the PIO informed the Commission that the appellants have filed as many as seven RTI applications on different dates, wherein, seeking directly or indirectly the same information's to his utter harassment. In other words, it is the plea of the PIO that the appellants have not filed almost all applications before him in no good faith or with bone-fide intents but appears to have been so filed those all applications for seeking directly or indirectly the same the information's at all times only with intent and purpose of harassing him. More particularly, according to him, one amongst those several applications, jointly being filed by the appellants on 08.03.2018, seeks the same and exact information's so sought in their subsequent application dated-20.09.2019, being subject-matter of this appeal, and the same which is subject-matter of the previous or another appeal registered in this Commission, being Appeal vide No.APIC-32/2018, is now lying pending disposal or sub-judice before the Hon'ble Gauhati High Court in WP(C)129/2018. The Commission, therefore, asked the PIO to file all his submissions in writing with support of all related records, if any, available in his office records. And, the PIO, whereupon, submitted his written submissions along with the related records before the Commission vide his letter No.DRG/GA/RTI-47/2018-19 dated-20.05.2019 with a request to dismiss or reject the appeal on the ground that the information sought, being subject-matter of this appeal, are the repetition of the information sought in the previous RTI application of the appellants filed by them in his office on 08.03.2018, being subject-matter of the another appeal vide APIC-32/2018, which is still lying sub-judice before Hon'ble High Court vide WP(C) 129/2018 as aforesaid.

I have also gone through the relevant contents of information's sought in the RTI application of the appellants filed on 08.03.2018 which reads as quoted — " Kindly inform as under with regard to subject citied above —

- 1. On 29.08.2017, Rs.25,00,000/-(twenty five lakhs) only was paid to YeshiTsewang through REF/CHQ NO.00000126433. Give detail reason for payment of this amount to this person.
- 2. On 06.09.2017, Rs.1000,000/-(ten lakhs) only was paid to YeshiTsewang through REF/CHQ NO.00000126437. Give detail reason for payment of this amount to this person.
- 3. On 07.09.2017, Rs.200,000/-(two lakhs) only was paid to LeikiKhandu through REF/CHQ NO.00000126438. Give detailreason for payment of this amount to this person.
- 4. On 11.09.2017, Rs.1000,000/-(ten lakhs) only was paid to LeikiKhanduThongkhar through REF/CHQ NO.00000126440. Give detailreason for payment of this amount to this person.
- 5. On 05.10.2017, Rs.00,000/-(three lakhs) only was paid to LeikiKhandu through REF/CHQ NO.000001264532. Give detail reason for payment of this amount to this person.
- 6. On 10.10.2017, Rs.50,000/-(fifty thousand) only was paid to LeikiKhanduThongkhar through REF/CHQ NO.00000126481. Give detail reason for payment of this amount to this person.
- 7. On 24.10.2017, 1000,000/-(ten lakhs) only was paid to 'Self' through REF/CHQ NO.00000126533. Give detail reason for payment of this amount to this person.
- 8. On 11.12.2017, 50,000/-(fifty thousand) only was paid to DorjeeKhandu through REF/CHQ NO.00000126539. Give detail reason for payment of this amount to this person.
- 9. On 18.12.2017, Rs.840,000/-(eight lakhs forty thousand) only was paid to LeikiSangia through REF/CHQ NO.00000126540. Give detail reason for payment of this amount to this person.

From comparing the contents of both application dated-08.03.2018 and application-20.09.2018 it transpires that the payment of land compensation amount of Rs.4,72,72,123/-(rupees four crores seventy two lakes seventy two thousand and one hundred twenty three) only against 27.55 acres of community land at Lishi

village, being subject in both applications and the numbers and details of information so sought in both applications are exactly the same with slight difference of use of words, like – the words used in application dated-08.03.2018 as ' **Give detail reason'** is the only difference of words used in application dated-20.09.2018 as '**Mention reason'** which gives the same meaning. But the date of payment of application fees of Rs.10/-(rupees ten) only against application dated-08.03.2018 vide challan 14263 dated-06.03.2018 is quite distinct and different from the challan payment of application fees of Rs.10/-(rupees ten) only vide challan No.6694 dated-18.09.2018 against application dated-20.09.2018.

Now, after hearing the PIO in person and also after having carefully read the contents of his written submissions with the contents of those other related documents enclosed therewith and also after having careful consideration of the other available materials on records coupled with the conduct or attitude of the appellants in remaining absent during all hearing without any information to or cooperation with the Commission, I have no hesitation in holding or in arriving at a conclusion that the appellants have not filed this appeal with clean breast, in as much as, it is evident on record that subject of the application, including, all 9(nine) numbers of information's and all details of information's sought in RTI application of the appellants which was jointly filed by them on 20th September, 2018 under Form-A of the RTI Act, being subject-matter of the present appeal vide No.APIC-16/2018, are exactly the same subject with same numbers and same details of information's sought in their previous RTI application jointly filed by them on 8th of March, 2018 under Form-A of the RTI Act, 2005. It is further established from the written and verbal submission of the PIO that the said previous RTI application of the appellants dated-08.03.2018 is the subject-matter of the previous appeal filed by the said appellants separately before the Arunachal Pradesh Information Commission as an another or separate appeal registered in the Commission, being appeal vide No.APIC-32/2018, which is informed to be lying pending disposal or sub-judice before the Hon'ble High Court in WP(C)129/2018. If furnishing or non-furnishing of those information's sought in the previous RTI application of appellants is a matter under challenge before the Honble High Court which is lying pending disposal or subjudice before it for a decision and leading thereby to the passing of a rule/order dated-21.03.2018 by the Hon'ble High Court in WP(C)129(AP)2018, whereby, staying the orderdated-28.02.2018, imposing a penalty of Rs.25000/-twenty five thousand) against the PIO, being passed by the Arunachal Pradesh Information Commission in Appeal No.APIC-32/2018, such filing of another RTI application at later stage on 20.09.2018, seeking the same or exact numbers and details of information of whose furnishing or non-furnishing to the appellants by the PIO is under challenge before any such court law for a proceeding or decision and the disclosure of which may thereby affect or interfere with such proceeding or decision of such court of law on such matter may amount to contempt of such court of law. Related context of the law as provided in clause (b) of sub-section-(1) of Section-8 of RTI Act, 2005 is, thus, referred herein as quoted - "8. (1) Notwithstanding anything contained in this Act, there shall be no obligation to give any citizen, -

(b) information which has been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court." That is to say, there shall be no obligation on the part of the PIO to give

any citizen — any information the disclosure of which may constitute contempt of court. Even otherwise, or without regard of the matter as discussed aforesaid, the RTI Act, 2005, also does not permit the citizen to file repeated applications at different stages, whereby, seeking the same information under the RTI Act. In the present case, the appellants have, thus, been found to have jointly filed the present appeal before the Arunachal Pradesh Information Commission without any disclosure of the fact that the numbers and details of information so sought in their RTI application dated-20.09.2018, being subject-matter of this appeal, are the same or exact numbers and details of information sought in their previous RTI application jointly filed by them before this Commission on 08.03.2018 and the same, as such, amounts to suppression of material facts before the Commission which is, thus, very much a valid ground for rejection of the appeal apart from the ground that such filing of repeated applications, seeking the same information's at different stages before the same public authority are not permissible under RTI Act, 2005.

In view of all above, I find this appeal fit to be rejected. And, accordingly, this appeal is rejected with an admonition to the appellants not to file such repeated applications at different stages for seeking the same information in the near future without which the same would be nothing but a misuse of the Act, leading either to undue harassment of the public authorities or to unnecessary wastage of time of the First and Second Appellate Authorities as provided under RTI Act, 2005. And, in the result, this appeal stands disposed off and closed. Judgment/order pronounced in the open Court today on this 3rd day July, 2019. JUDGMENT/ORDER

This is a second appeal filed by the appellant under sub-section (3) of Section-19 of the RTI Act, 2005. Brief fact of the case is that one Shri KurungDolo, appellant of this appeal filed an RTI application under Form-A before the PIO-cum-EE, PWD, Jairampur Division, Changlang District, on 04.02.2019, whereby, seeking various information's, regarding fund sanctioned under SADA and SIDF during the year of 2017-18against the name of works as follows:

- (1) Extension of Mio Township road (3.00 Km) (SH:Earth works & CD works).
- (2) Re-carpeting of Kharsang Township road (3.00 Km)
- (3) C/o Multi-purpose Hall near Living Hope School at Nongtham.
- (4) C/o Infrastructure Development at General Ground, Kharsang in Changlang District, Jairampur.
- (5) C/o Double Storied School Building at Lower Miao.

This application of the appellant was received by the PIO on the same date of submission of the application on 04.02.2019, in as much as, the person receiving the application duly acknowledged the receipt of the application on the body of the application. But the appellant did not get any response from the PIO and, being aggrieved of the same, the appellant filed the First Appeal before the SE-cum-FAA (First Appellate Authority) on 08.03.2019. And, the appellant again, having failed to receive the information so sought from the First Appellate Authority, filed this Second Appeal on 03.05.2019 before the Commission under sub-section (3) of Section-19 of the RTI Act. The Registry of the Commission (APIC), having receipt of the appeal, registered the

same as APIC No.69/2019 and, thereafter, issued necessary processes for hearing of the appeal.

Accordingly, this appeal came up before the Commission for 3(three) consecutive times for hearing on 12.06.2019, 24.07.2019 and on 21.08.2019. In the course of hearing of the appeal the appellant remained present almost on all dates of hearing but the PIO, instead of attending the hearing in person before the Commission, deputed his Assistant Engineer for attending the hearing of the appeal in his behalf. In the first hearing of the appeal on 12.06.2019 his Assistant Engineer Mr. Okep Dai attended the hearing but he did not have any dispute as to the fact that the PIO had already failed to furnish the information sought to the appellant within prescribed period of 30 days as provided in sub-section (1) of Section-7 of the RTI Act, 2005. However, the said representative of the PIO expressed his readiness on behalf of the PIO to furnish all information's sought to the appellant with an assurance to furnish the same within a period of 20 days time and in the event of his failure to do so to be imposed reasonable penalty upon him which was agreed upon by the appellant. And, in terms of such assurance given by the representative of the PIO, the Commission directed the PIO to furnish all information sought to the appellant within a period of 20 days time from this date of first hearing of the appeal and failing which to be imposed a reasonable penalty on the PIO and fixed the next date of hearing of the appeal for disposal on 24.07.2019.

On the next fixed on 24.07.2019 PIO, in lieu of his appearing the hearing in person, again deputed his another AE Mr. Taw Kero for representing him in this second hearing of the appeal. It is now pertinent to point out herein that 20(twenty) days time given to the PIO for furnishing all information's sought to the appellant expired on 02.07. 2019 but the PIO failed to furnish all information's sought to the appellant within the said assured period of 20 days time. The facts, therefore, remain that the PIO, who has already been found failed to furnish the information within prescribed period of 30 days in clear violation of sub-section (1) of Section-7 of the RTI Act, was again found to have failed to comply with the direction of the Commission passed during first hearing of the appeal on 12.06.2019 to furnish all information sought to the appellant within 20 days time from the said date of hearing. The said Officer representing the PIO in the second hearing on 24.07.2019 also could not make any explanation to the Commission as to why the PIO had failed to comply with such direction of the Commission to furnish the information sought to the appellant in 20(twenty) days time. Not only that the said representative of the PIO appeared to have no any knowledge about the said order passed by the Commission in the first hearing of the appeal and was found attending this second hearing without any readiness or preparation for furnishing of the information sought to the appellant and the same, as such, gave rise to a circumstance appearing to be that he had been deputed by PIO to appear before the Commission in his behalf in the second hearing of the appeal without any proper instruction, whereby, leading to denial of all information to the appellant from beginning until this second hearing of the appeal. The Commission, in view of such facts and circumstances as aforesaid, observed that Er. Mitun Mize, PIO-cum-EE, PWD, Joirampur Division, Changlang District of Arunachal Pradesh was found prima-facie liable for imposing reasonable penalty for his refusal in furnishing the information sought within prescribed period of 30 days in violation of sub-section (1) of Section-7 of the RTI Act, including, for his neglect towards order/direction of the Commission, whereby, leading to denial of information to the appellant from beginning till the stage of second hearing of this appeal. However, with a view to afford him an opportunity of hearing in terms of the law as provided in the first proviso to sub-section (1) of Section-20 of the RTI Act as to why he should not be imposed penalty for his denial or refusal to furnish the information so sought under RTI Act to the appellant within prescribed period of 30 days as provided in sub-section (1) of Section-7 of the Act, a show cause notice dated-25.07.2019 was issued against him to the said effect with a further direction to him to appear before the Commission in person on 21.08.2019 at 10.30 AM for furnishing replies to the show cause notice or to explain away the circumstances about why he should not be imposed a reasonable penalty in terms of the law as provided under sub-section (1) of Section-20 of the Act.

Finally, today, i.e, this 21st day of August, 2019 is the date fixed for personal appearance of the PIO before the Commission for furnishing replies to the Show Cause Notices issued against him or for explaining away the circumstances, if any, about why he should not be imposed penalty under sub-section (1) Section-20 of the RTI Act. Appellant Shri KurungDolo is present. PIO Er. Mitun Mize, is, though not present, again represented by his Assistant Engineer, Mr. Okep Dai, who represented him (PIO) during first hearing of the appeal and the both appellant and representative of the PIO present being heard.

In the course of hearing the appellant informed the Commission that the PIO has not furnished him all information sought within the assured period of 20 days in complete disregard of the direction passed by the Commission in the first hearing of the appeal to furnish all information sought to him (appellant) in 20 days from the date of the order. Appellant, infact, admitted to have received some of the information's so sought but again informed to have not been furnished some of the information sought by him in his application under Form-A and amounted thereby to furnishing of incomplete information in terms of RTI Act and that such partly furnishing of information's so sought under RTI Act was not only an act of furnishing incomplete information under RTI Act but the same had also been sent by post after lapse of more than a month of the date of the order aforesaid in clear violation of order passed by the Commission during first hearing of the appeal to furnish him all information's sought in 20 days time from the date of the order.

Mr. Okep Dai, Assistant Engineer, informed the Commission that he is representing the PIO and submitted a letter vide No.JD/RTI/2019-20/1461-62 dated-14.08.2019 being sent by the PIO to the Commission, wherein, informing the Commission that he would not be able to attend the hearing today as he would be going for a 5(five) days training to be held from 19th to 22nd of August, 2019 at CVRI-Roorki, Uttrakhand. In this context it is pertinent to mention herein that today is date specifically fixed for hearing of the Show Cause Notice issued against Er. Mitun Mize the PIO-cum-EE, PWD, Joirampur Division, Chanlang District, Arunachal Pradesh, with intent and purpose of giving him an opportunity of representation or explanation as to why he should not be imposed penalty under sub-section (1) of Section-20 of the RTI Act. But, surprisingly, the PIO, instead of availing the opportunity of making appearance or representation for explaining away the circumstance, if any, as to why he should not be imposed penalty, has again deputed his Assistant Engineer Mr. Okep Dai to represent him and to hand over his said letter dated-14.08.2019 to the Commission which discloses, inter-alia, about his inability to appear the hearing as aforesaid but without a whisper of the show cause notice dated-25.07.2019 issued against him. It is pertinent either to remind herein also that the Commission observed and ordered during second hearing of the appeal on 24.07.2019 in the presence and hearing of the representative of the PIO Er. Taw Kero (Assistant Engineer) to the effect that the PIO, being prima-facie found liable for imposing penalty under sub-section (1) of Section-7 of the Act, shall be issued a show cause notice with a direction to him to furnish the replies to the show cause notice on the next date of hearing fixed today on 21.08.2019. I have, therefore, a reason for believing or presuming under the law that the PIO, who was being duly represented by his AE Mr. Taw Kero during second hearing of the appeal, was well informed of such observation made and order passed against him by the Commission for issue of a show cause notice against him and for furnishing of replies thereof on this date fixed today. That is to say, the PIO, who is presumed under the law to have been well informed of the observation and order passed against him as aforesaid, had sufficient time for preparing his written replies or explanation to the show cause notice which could have been sent through the officer representing him in the hearing today, if he could not be personally present due to any such unavoidable circumstances as mentioned in his letter to the Commission as mentioned hereinbefore. And, therefore, now the fact remains that the PIO has failed to avail the opportunity given to him for explaining away the circumstance, if any, as to why he should not be imposed penalty under sub-section (1) of Section-20 of the RTI Act, 2005 and, in the whole, it is, thus, observed that neither the PIO himself nor those officers deputed by him for representing him during hearing of this appeal has been able to give any reason or to explain away the circumstance, if any, about why the PIO had denied or refused to furnish the information sought to the appellant within prescribed of 30 days as provided in sub-section (1) of Section-7 of the RTI Act and in absence of which there is no escape from concluding that the PIO had denied or refused to furnish the information sought under RTI Act to the appellant within prescribed period of 30 days without any valid reason thereof and the same, as such, amounts to clear violation of the provision of sub-section (1) of Section-7 of the RTI Act liable for imposing a reasonable penalty under sub-section (1) of Section-20 of the Act.

Considering the facts and circumstances as aforesaid I have arrived at a conclusion that the PIO is fit or liable for imposing penalty under sub-section (1) of Section-20 of the RTI Act, 2005. And, accordingly, I do hereby order and direct as under:

- 1. Er. Mitun Mize, PIO-cum-EE, PWD, Joirampur Division, Changlang District, Arunachal Pradesh, shall pay a fine of Rs.25,000/-(rupees twenty five thousand) only for his refusal to furnish the information sought within prescribed period of 30 days without any valid reason. Such payment of fine shall be made through challan payment in favour of the Registrar of the Arunachal Pradesh Information Commission, Itanagar, in the head of account vide No.0070 within a month from the date of receipt of this judgment/order.
- 2. He shall pay a compensation amount of Rs.10,000/-(rupees ten thousand) only to the appellant and the payment whereof shall be made in any mode convenient to the PIO (judgment-debtor) within a month from the date of receipt of this judgment/order.
- 3. He shall furnish all information's sought in complete to the appellant within a month time from the date of receipt of this order.
- 4. Provision of sub-section (2) of Section-20 of the RTI Act, 2005 may be invoked for a disciplinary proceeding against him in the event of his default of payment of fine or

compensation or of his failure to comply with all or any of the above orders passed against him (PIO).

JUDGMENT/ORDER

Whereas, an appeal under section 19(3) of RTI Act, 2005 has been received from Shri HillangTadh, D-sector, B-Extension (1), PO/PS Itanagar, Arunachal Pradesh, for non-furnishing of information, by The Public Information Officer-cum-Deputy Director of School Education, Yupia, Papum Pare District, Govt. of Arunachal Pradesh, as sought, by the appellant under section 6(1) of RTI Act, 2005 on 03/06/2019.

Whereas, the 1st hearing was held on 09.09.2019. The Respondent Public Information Officer-cum- Deputy Director of School Education, Yupia, Papum Pare District, Govt. of Arunachal Pradesh, was represented by Shri Dariak Nabam Hina, APIO -cum- Coordinator (Esst) O/o the Deputy Director of School Education, Papum Pare District, Yupia, was present, while The appellant, Shri HillangTadhwas

also present. Heard both the parties. During the hearing the APIO assured that he will furnish all information in complete as per Form 'A' on 09th September 2019. He had submitted his undertaking which is enclosed herewith.

While, the appellant Shri Hillang Tadh shall inform this commission on receiving the information from APIO and as to whether he has satisfied/ not satisfied with the information so furnished by APIO. And on the basis of reply from APIO this Commission shall decide as to whether another hearing is necessary on the matter. Hence for the time being no notice is being issued for the next hearing.

Both the APIO and Appellant heard, in their presence.

The Appellant Shri HillangTadh is given oneweek time for perusal of the documents which would be provided to him by the PIO of this instant case.

With the above directions, this case is reserved till 16th September 2019.

With continuation of the hearing held on dated 09.09.2019, and application dated 19.09.2019 has been received from the appellant Shri HillangTadh, stating that he had received all the documents/information furnished by the PIO and satisfied with the documents furnished by the PIO of this instant case and requested for closure of the instant case.

The Commission is of the view that on perusal of all records, it is found that no further hearing is required on the same case. Since the appellant had received the complete information in all respected and satisfied himself. Hence this case deemed fit for disposal and stands case is disposed of today, the 30th September' 2019.

JUDGMENT/ORDER

The appeal under section 19(3) of RTI Act, 2005 has been received from Shri NabamTapakLekhi village Naharlagun Near, Mahindra Dealer Back side Nirjuli, Papum Pare District, Arunachal Pradesh, for non-furnishing of information, by The Public Information Officer-cum-BDO-cum-programme Officer, CD block Mengio, Arunachal Pradesh, as sought, by the appellant under section 6(1) of RTI Act, 2005 on 01.07.2019.

The 1st hearing was held on 11.11.2019, The Respondent Public Information Officer Dr. Rubu Tabiyo, BDO-cum-programme Officer CD block Mengio was

absent, while the appellant Shri Nabam Tapak, Lekhi village Naharlagun, Papum Pare District, Arunachal Pradesh were present in court proceeding.

Heard the appellant, Appellant informed that PIO has not furnish information at Sl.No.1 in Form 'A' as sought by the appellant under sub section (1) of section 6 of RTI Act. 2005. Now the PIO is given reasonable opportunity of being heard before taking any action against thereof and he is directed to appear in person along with the information/documents within 2 (Two) weeks from the date of issue of this notice. Further, take notice that failing to complythe order shall initiate appropriate action as deemed fit under provision of RTI Act, 2005.

The 2nd hearing was held on 02.12.2019. The Respondent Public Information Officer and the appellant Shri NabamTapak, were present in court proceeding.

Heard both the parties, The PIO assured that he will furnish the information as per master roll i.e. money receipt of each individual within 30 days. The next hearing is fixed on 06 January 2020. No formal notice for hearing shall be issued separately.

Whereas the 3rd hearing was held on 06.01.2020. The Respondent Public Information Officer Dr. Rubu Tabiyo, BDO-cum-programme Officer CD block Mengio was present, while the appellant Shri NabamTapak, Lekhi village Naharlagun, Papum Pare District, Arunachal Pradesh was also present in court proceeding.

Heard both the parties. The PIO assured that he will furnish the information in complete form by the next hearing which is fixed on 20th January 2020. The appellant complained that the PIO has not furnish the information as per the application filed by him. He was not satisfied with the incomplete information furnish by the PIO. As such PIO was again directed to furnish the complete information in all respect. No formal notice shall be issued for hearing

In the 4th hearing held on 20.01.2020.The Respondent Public Information Officer Dr. RubuTabiyo, BDO-cum-programme Officer CD block Mengio was absent, while the appellant Shri NabamTapak was present in court proceeding.

Heard the appellant. The appellant informed that he had not received any information till date i.e. 20th January 2020 from the Concerned PIO who had assured to provide information / documents on the hearing held on 06th January 2020 in Form 'A' SI No. 1. Photo copy of wages received records maintained by GPM/Interim Committee during distribution of MGNREGA wage to the beneficiaries. Further appellant stated that the respondent PIO has furnished incomplete documents/misleading information and not satisfied with the information.

After perusal of the records available, the Commission directed the PIO Dr. RubuTabiyo, BDO-cum-programme Officer CD block Mengio, to furnish complete information to the appellant on or before 3rd February 2020, failing which penalty under section 20 (1) of the Right to Information Act 2005 would be imposed upon him in the next hearing and take this as showcause notice. This showcause notice should be served to the PIO for not furnishing the complete and correct information as sought by appellant. He cannot delay or deny information to any information seekers under RTI Act. 2005.

Whereas the 5th hearing was held on 10.02.2020. The Respondent Public Information Officer and appellant both were present in the hearing.

While, the appellant Shri NabamTapak had submitted an application stating that, he had received all the information in complete from the PIO and satisfied with the information/documents furnished by the PIO of this instant case and requested this Commission for closure of the instant case. The appellant submitted written application in this regard which is enclosed herewith. And appellant has requested that to compensate for the lost while failing this case and it took lots of time to receive all the information from PIO. The PIO agreed to compensate Rs. 10,000/-(Rupees Ten thousand) only within one week for the expenditure incurred by Shri NabamTapak (appellant).

The PIO must also pay the compensation amount of Rs. Rs. 10,000/- (Rupees Ten thousand) only, under section 19 (8) (b) - "require the public authority to compensate the complainant for any loss or other detriment suffered;" to the appellant Shri NabamTapak directly and inform this Commission's on the action taken.

Therefore, the Commission is of the view that no further hearing is necessary on same case and the case is deemed fit for disposal. Hence, the instant case is herewith disposed off. This judgment order be forwarded to both the parties accordingly.
